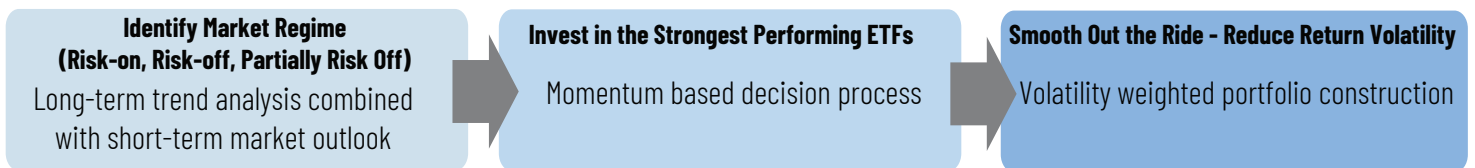

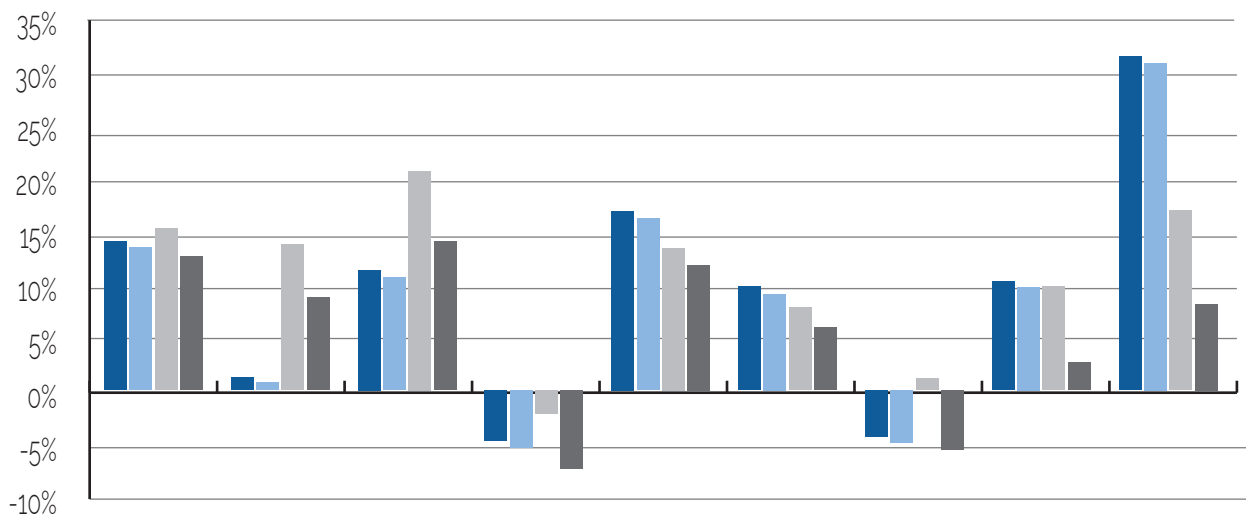

Julex Annual Composite Returns (USD)

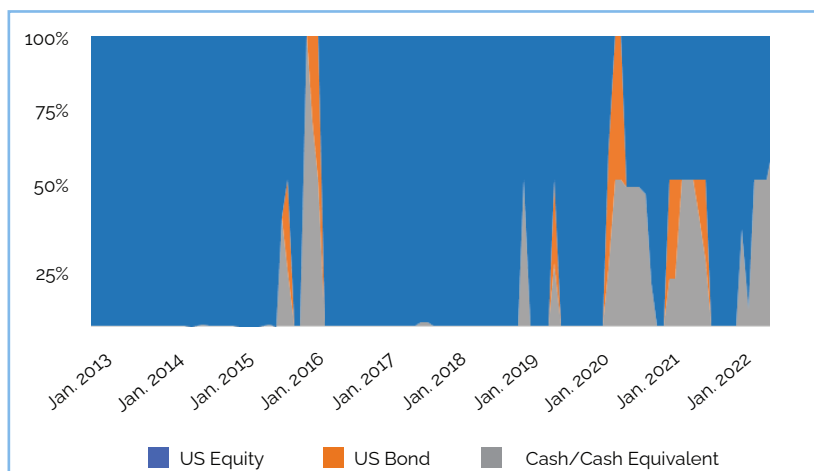
