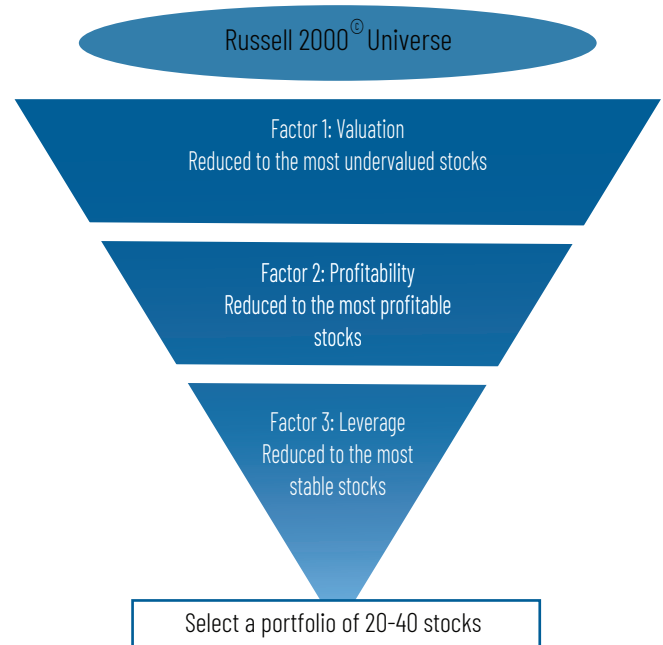

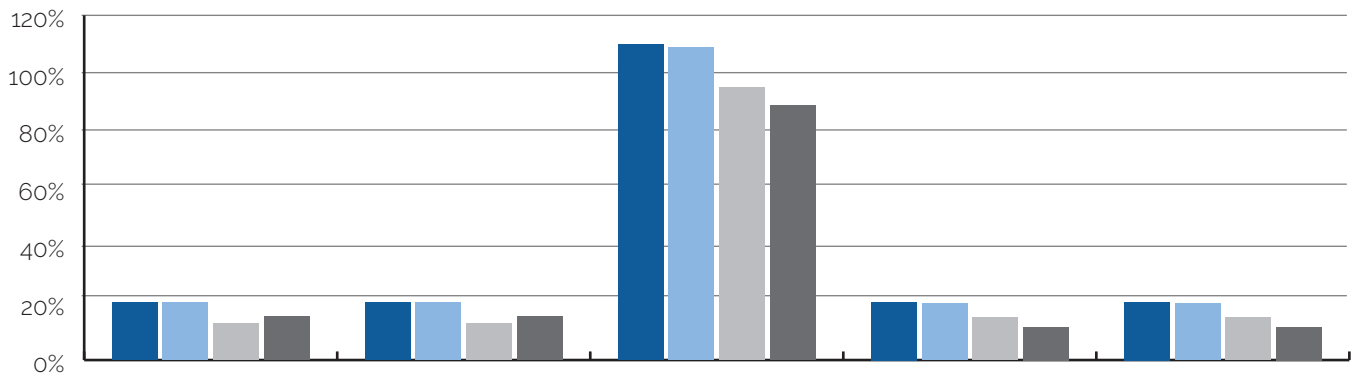

Julex Trailing Composite Returns Through 3/31/2021 (USD)

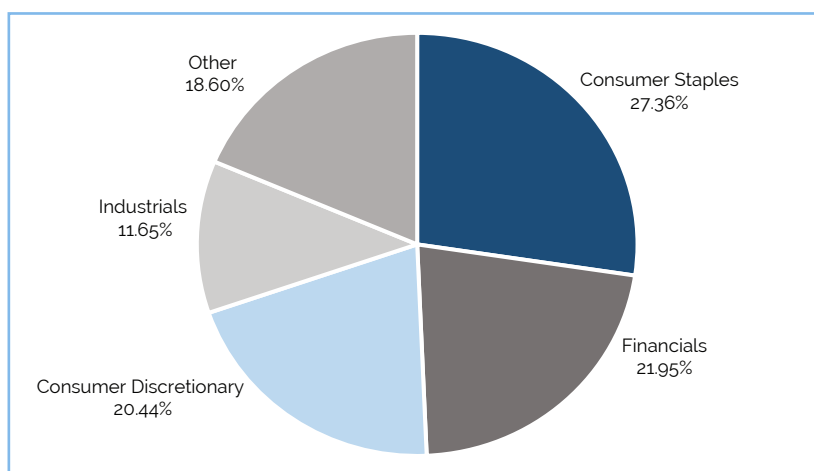
